

SUBSTITUTION OF TRUSTEE

WHEREAS, on October 28, 1995, Steven Zufelt and Sharon B. 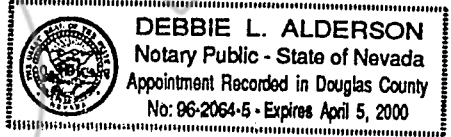
