## SUBSTITUTION OF TRUSTEE AND RECONVEYANCE

THIS SUBSTITUTION OF TRUSTEE AND RECONVEYANCE is entered into this date, June 22, 1998, by and between AMERICAN SECURITIES COMPANY, a California Corporation ("Successor Trustee"), and THE BANK OF NEW YORK Trustee under the Pooling & Servicing Agreement Series 1995-Nat Barclay Street, New York, NY 10286, Corp.
