### SHORT FORM DEED OF TRUST

This Deed of Trust is made on October 21, 1998 by

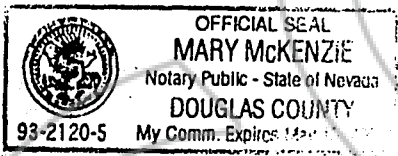

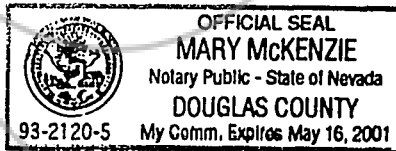
