

COMES NOW, Plaintiff KATHLEEN A. BURNELL, by and
through GARY L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and
Defendant, EDWARD P. BURNELL, who hereby agree and stipulate as
follows:

1. That in an Order filed February 11, 1992, in the
Superior Court of New Jersey, Chancery Division, Family Part,
Ocean County, Defendant was ordered to pay the sum of \$132.00
per week as child support of his minor child EDWARD P. BURNELL,
born January 6, 1986, and \$100.00 per week as spousal support.

1 2. That in the above-mentioned Order, judgment was
2 entered in favor and Plaintiff and against Defendant in the
3 amount of \$4,846.00 for child support arrears.

4 3. That Defendant owes \$2,140.00 in child support
5 arrearages through and including September 4, 1998.

6 4. That Defendant currently earns \$1,300.00 per
7 month, working for Cactus Jacks Casino in Carson City. Based
8 upon Defendant's monthly income and applying the formulas set
9 forth in NRS 125B.070, to wit: 18%, Defendant's monthly child
10 support obligation is \$249.00.

11 5. That Plaintiff currently provides health insurance
12 coverage for the parties minor child at a cost of \$71.27 every
13 two weeks. That Defendant agrees to pay one-half or \$71.00 of
14 Plaintiff's insurance costs per month.

15 6. That therefore the Defendant shall pay \$249.00
16 per month as ongoing support, plus \$71.00 per month for one-half
17 of Plaintiff's insurance premiums and 25.00 per month toward
18 satisfaction of Defendant's child support arrears for a total of
19 \$345.00 per month. Defendant's first \$345.00 monthly payment
20 shall be due on October 1, 1998, and continue due on the 1st
21 day of each and every month thereafter until further order of
22 this Court.

23 7. The parties stipulate and certify that the amount
24 of support is consistent with the appropriate formula set forth
25 in NRS 125B.070(1)(b).

26 8. That Defendant's child support payments shall be
27 made by wage withholding.

2 9. Defendant understands that, in the event he
3 becomes unemployed or underemployed, all child support payments
4 to be made by him to Plaintiff must be in the form of a
5 cashier's check, certified check, or money order, or in cash.
6 The Defendant further understands that if the payment is in the
7 form of cash it must be delivered to the Douglas County Clerk at
8 her office in Minden, Nevada. If the payment is in the form of
9 a cashier's check, certified check, or money order, Defendant
10 understands that it must be made payable to the DOUGLAS COUNTY
11 CLERK, with the notation Case No. 980015 (EDWARD P. BURNELL),
12 and be either mailed to the Douglas County Clerk at Post Office
13 Box 218, Minden, Nevada 89423, or delivered to said County Clerk
14 at her office in the Law and Judicial Center, 1625 8th Street,
15 Minden, Nevada.

16 10. That pursuant to NRS 125B.080(7), expenses for
17 health care which are not reimbursed through insurance,
18 including expenses for medical, surgical, dental, orthodontic
19 and optical expenses, must be borne equally by both parents in
20 the absence of extraordinary circumstances.

21 11. Defendant agrees that he shall notify the Douglas
22 County District Attorney's Office in writing within 10 days of
23 any change in Defendant's mailing address, home address, or
24 employment.

25 12. Defendant understands that this support order may
26 be reviewed every three years at the request of either party in
27 accordance with NRS 125B.145.

1 13. Defendant understands that failure to pay his
2 support as required by the order entered in accordance with this
3 stipulation will subject him to possible contempt of court with
4 a penalty of 25 days in jail.

5 14. That except as modified herein the terms and
6 conditions of the Order entered February 11, 1992, in the
7 Superior Court of New Jersey, Chancery Division, Family Part,
8 Ocean County, remain in full force and effect.

9 15. Defendant understands that monthly periodic
10 payments ordered in accordance with this Stipulation do not
11 preclude the use of other means to collect any arrears or
12 enforce this order, including garnishment, liens, attachments,
13 execution on real or personal property or interception of
14 federal income tax refunds.

15 16. In accordance with 125B.055, Plaintiff and
16 Defendant shall file with the Court and with the District
17 Attorney's Office their social security number, residential and
18 mailing addresses, telephone number, driver's license number,
19 and the name, address and telephone number of their employer.

20 18. That pursuant to Chapter 130 of the Nevada
21 Revised Statutes the above entitled court assumes continuing
22 exclusive jurisdiction (CEJ) over the resulting controlling


