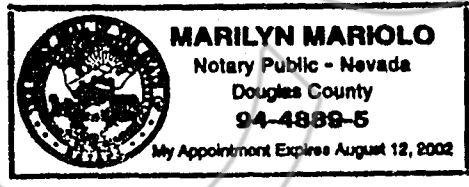

16 COMES NOW, Plaintiff SANDRA SAMANIEGO, by and through

17 GARY L. KENDRICK, DEPUTY DISTRICT ATTORNEY, and Defendant, JESUS

18 J GANDARA , who hereby agree and stipulate as follows:

19
20 1. Defendant JESUS J. GANDARA, admits that he is the
21 father of, and owes a duty of support to, his minor child
22 AMBER M. GANDARA Born: 08/20/96.

23 2. That Plaintiff and Defendant were never married but
24 cohabited together until April 1998 at which time they separated.

25 3. That Defendant's gross monthly income is
26 approximately \$1,733.33, and his monthly child support
27 obligation is 18% of his monthly income in accordance with NRS

2 10. Defendant understands that, in the event he becomes
3 unemployed or underemployed, all child support payments to be
4 made by him to plaintiff, must be in the form of a cashier's
5 check, certified check, or money order, or in cash. The
6 defendant further understands that if the payment is in the form
7 of cash it must be personally delivered to the Douglas County
8 Clerk. If the payment is in the form of a cashier's check,
9 certified check, or money order, Defendant understands that it
10 must be made payable to the DOUGLAS COUNTY CLERK, with the
11 notation Case No. 980150 (JESUS J GANDARA), and be either
12 mailed to the Douglas County Clerk at Post Office Box 218,
13 Minden, Nevada 89423, or delivered to said County Clerk at her
14 office in Minden, Nevada.

15 11. That Defendant shall notify the Douglas County
16 District Attorney's Office in writing within 10 days of any
17 change in defendant's mailing address, home address, or
18 employment.

19 12. Defendant understands that the resulting order may
20 be reviewed every three years at the request of either party in
21 accordance with NRS. 125B.145.

22 13. That custody of the minor child shall remain with
23 the mother, SANDRA SAMANIEGO. This provision is made under
24 authority of NRS 126.031, and is made for the protection of the
25 minor child. The parties' understand that the Douglas County
26 District Attorney's Office does not have authority to litigate
27 matters regarding custody and visitation.

1 125B.070. Based upon Defendant's monthly income and applying the
2 formulas set forth in NRS 125B.070, to wit: 18%, Defendant's
3 monthly child support obligation is \$310.00.
4

5 4. Therefore Defendant shall pay \$346.00, to be
6 applied as follows: \$310.00 as ongoing child support; \$31.00
7 towards satisfaction of Defendant's child support arrears of
8 \$930.00 and \$5.00 for half of Plaintiff's monthly insurance
9 premium which she pays for minor child.

10 5. That Defendant's first \$346.00 monthly child
11 support obligation shall be due on November 1, 1998, and on the
12 first day of each and every month thereafter until further order
13 of this Court.

14 6. Defendant acknowledges hat he owes \$930.00 in child
15 support arrears for the period of April 1998 through and
16 including October 1998. That Judgment may be entered against
17 Defendant in the amount of \$930.00 for child support arrears.

18 7. The parties stipulate and certify that the amount
19 of support is consistent with the appropriate formula set forth
20 in NRS 125B.070(1)(b).

21 8. That Plaintiff is currently providing health
22 insurance for the parties minor child. That however, and
23 pursuant to NRS 125B.080(7), expenses for health care which are
24 not reimbursed through insurance, including expenses for
25 medical, surgical, dental, orthodontic and optical expenses,
26 must be borne equally by both parents.


27 9. That Defendant's child support payments shall be
28 made by wage withholding.

2 14. Defendant understands that failure to pay his
3 support as required by the order entered in accordance with this
4 stipulation will subject him to possible contempt of court with
5 a penalty of 25 days in jail.


6 15. Defendant understands that monthly periodic
7 payments ordered in accordance with this Stipulation do not
8 preclude the use of other means to collect any arrears or
9 enforce this order, including garnishment, liens, attachments,
10 execution on real or personal property or interception of
11 federal income tax refunds.

12 16. In accordance with 125B.055, Plaintiff and
13 Defendant shall file with the Court and with the District
14 Attorney's Office their social security number, residential and
15 mailing addresses, telephone number, driver's license number,
16 and the name, address and telephone number of their employer.
