

If the payment is in the form of a cashier's check, certified check, or money it must be order, pavable to the DOUGLAS COUNTY CLERK. must contain 960346 (DIAZ), and be either mailed the notation Case No. the Douglas County Clerk at Post Office Box 1240, Minden, 89423, or delivered to said County Nevada Clerk office in the Law and Judicial Center, 1625 8th Street, Minden, Nevada.

That Defendant secure and maintain medical health insurance on the above named child when available through employment or other group policy. The Defendant is ordered to provide the Douglas County District Attorney's Office, Child Support Division information regarding the availability of health insurance.

That the child's birth certificate shall be amended in accordance with NRS 126.161 to show that JUAN GABRIEL DIAZ is the father of JOSHUA MILLER-DIAZ, Born: 08/08/96.

That custody of the minor child shall remain with the maternal grandmother, PAULA MILLER. This provision is made under the authority granted in NRS 126.031, and is made for the protection of the minor child. That the Douglas County District Attorney's office does not have authority to litigate matters regarding custody and visitation.
