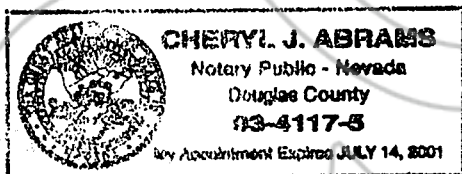

DEFAULT ORDER AND JUDGMENT

This Court has reviewed Plaintiff's Application for Default Judgment and all pleadings and papers on file herein, and makes the following Findings and Order by way of default.

AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

That the Court has jurisdiction over the parties and the subject matter of this case.

That the Defendant was personally served with a copy of a Notice of Finding of Financial Responsibility on July 20, 1998.

That the Defendant has failed to answer, request a meeting with the District Attorney's Office, Child Support

1 Division, or otherwise appear in this matter after being
2 properly served.

3 That the Defendant is the parent of, and owes a duty
4 of support to: JOSHUA DIAZ-MILLER, born: 08/08/96; Social
5 Security # [REDACTED] 5175.

6 That based upon Nevada average wage, Defendant's
7 current monthly child support obligation for one child is
8 \$403.00.

9 That the Defendant owes child support arrears in the
10 amount of \$10,881.00 for the period August 1996 through and
11 including October 1998.

12
13 THEREFORE, IT IS HEREBY ORDERED THAT:

14 That the Defendant is the parent of, and owes a duty
15 of support to: JOSHUA MILLER-DIAZ, born: 08/08/96; Social
16 Security # [REDACTED] 5175.

17 Judgment is entered in favor of Nevada State Welfare
18 and MELISSA MILLER against Defendant in the amount of
19 \$10,881.00 for the period August 1998 through and including
20 October 1998.

21 That Defendant pay \$443.30 per month, by wage
22 withholding, to be paid as follows:

23	CHILD SUPPORT:	\$403.00
24	ARREARAGE PAYMENT:	\$40.30
25	MEDICAL INSURANCE PREMIUMS:	\$-0-
26	PATERNITY BLOOD TEST COSTS:	\$-0-
27	MEDICAL EXPENSE REIMBURSEMENT:	\$-0-
28	SPOUSAL SUPPORT:	\$-0-
	TOTAL:	\$443.30

1 PAYMENTS MUST BE MADE TO THE DOUGLAS COUNTY CLERK AS FOLLOWS:

2 That Defendant's monthly child support payments
3 shall be in the form of a cashier's check, certified check, or
4 money order, or in cash. If the payment is in the form of
5 cash, it must be delivered to the Douglas County Clerk at her
6 office in Minden, Nevada. If the payment is in the form of a
7 cashier's check, certified check, or money order, it must be
8 made payable to the DOUGLAS COUNTY CLERK, must contain
9 the notation Case No. 960346 (DIAZ), and be either mailed to
10 the Douglas County Clerk at Post Office Box 1240, Minden,
11 Nevada 89423, or delivered to said County Clerk at her
12 office in the Law and Judicial Center, 1625 8th Street, Minden,
13 Nevada.

14 That Defendant secure and maintain medical health
15 insurance on the above named child when available through
16 employment or other group policy. The Defendant is ordered to
17 provide the Douglas County District Attorney's Office, Child
18 Support Division information regarding the availability of
19 health insurance.

20 That the child's birth certificate shall be amended in
21 accordance with NRS 126.161 to show that JUAN GABRIEL DIAZ is
22 the father of JOSHUA MILLER-DIAZ, Born: 08/08/96.

23 That custody of the minor child shall remain with the
24 maternal grandmother, PAULA MILLER. This provision is made
25 under the authority granted in NRS 126.031, and is made for the
26 protection of the minor child. That the Douglas County
27 District Attorney's office does not have authority to litigate
28 matters regarding custody and visitation.

1 The Defendant shall notify the Douglas County District
2 Attorney's office of any change in Defendant's home address,
3 mailing address, telephone number, employment, or medical
4 insurance availability within ten days of any change.

5 In accordance with 125B.055, Plaintiff and Defendant
6 are hereby ordered to file with the Court and with the district
7 attorney's office their social security number, residential and
8 mailing addresses, telephone number, driver's license number,
9 and the name, address and telephone number of their employer.

10 **IT IS FURTHER ORDERED THAT:**

11 That Defendant's first monthly child support
12 obligation shall be due on November 1, 1998 and shall continue
13 due on the First day of each and every month thereafter until
14 further order of this Court.

15 That when Defendant's minor child emancipates,
16 Defendant shall continue to pay \$403.00 per month toward
17 satisfaction of defendant's then existing child support arrears
18 in accordance with NRS 125B.100.

19 That Defendant's ordered monthly payment on child
20 support arrearages does not preclude other methods of collection
21 for child support arrearages which may include, but are not
22 limited to wage withholding, garnishments, liens and the
23 interception of Federal Income tax refunds, will be undertaken
24 upon entry of this Order.


