undivided one-eighth (1/8) interest, in that certain real property situate in the County

TO HAVE AND TO HOLD the said presents, together with the appurtenances, unto the said party of the second part and to his successors and assigns forever.

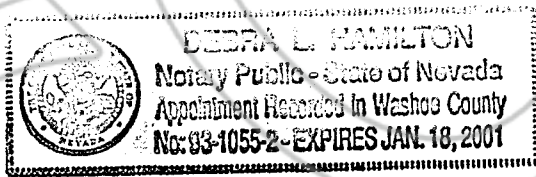
