1. 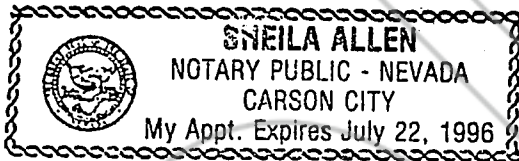

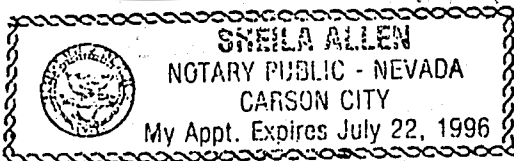
