

RESCISSION OF NOTICE OF DEFAULT AND ELECTION TO SELL

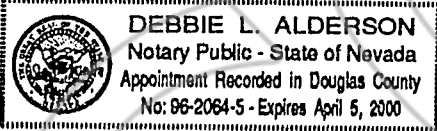
