SHORT FORM DEED OF TRUST

This Deed of Trust is made on February 19, 1999 by MARY MCKENZIE, AN UNMARRIED PERSON

(collectively and individually "Trustor"); Equitable Deed Company ("Trustee"); and the beneficiary, Bank of America NT&SA, a national banking association ("Bank"). Trustee is a subsidiary of Bank. Bank and I agree:
