13 IT IS HEREBY STIPULATED AND AGREED by and between

14 PROVIDIAN NATIONAL BANK fka FIRST DEPOSIT NATIONAL BANK, ("Plaintiff"),

15 and DIANE L. JOHNSON, ("Defendant"); that Judgment be entered in favor of the Plaintiff

16 and against the Defendant for the amount of \$ 5,095.85, plus interest on the principal balance in

17 the amount of \$ 372.93, along with Plaintiff's costs of suit in the amount of \$ 154.00, and Plaintiff's

18 attorney's fees in the amount of \$ 320.00, less amount paid of \$ 883.85, together with interest on

19 the principal balance at the mutually agreed upon contract rate of (15.90%) per annum from the

20 date of the filing of the Complaint until this debt is paid in full.

21 It is further stipulated and agreed that this Judgment shall be paid as follows:

23 1. Payments shall be made in an amount of no less than \$ 146.00 per month by

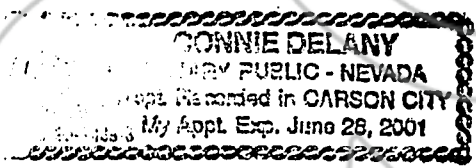
