

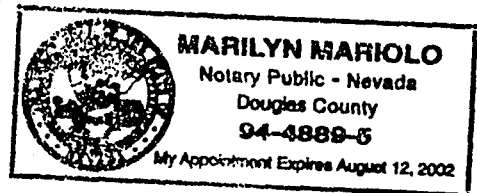

dismissal without prejudice in the above-entitled action.

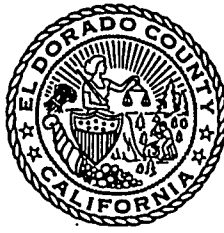
