SUBORDINATION AGREEMENT

THIS AGREEMENT, made and entered into this ______ day of _______, 1999, by and between SILVERMAN & DECARIA, CHTD., a Nevada Professional Corporation (hereinafter referred to as "Creditor") and DR. DAN ROWE and MS. JAN ROWE (hereinafter referred DR. Jan & Arlene Cichowlys to as "Debtors").


