### SHORT FORM DEED OF TRUST

This Deed of Trust is made on April 7, 1999 by ADOLPH A. SCHONDER AND KATHLEEN M. SCHONDER, AS TRUSTEES OF THE SCHONDER FAMILY TRUST DATED SEPTEMBER 16, 1993

(collectively and individually "Trustor"); Equitable Deed Company ("Trustee"); and the beneficiary, Bank of America NT&SA, a national banking association ("Bank"). Trustee is a subsidiary of Bank. 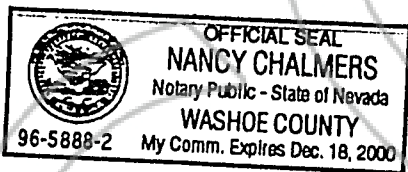
