SHORT FORM DEED OF TRUST

This Deed of Trust is made on May 4, 1999 by PATRICIA JEANNE HELLMAN, AN UNMARRIED PERSON

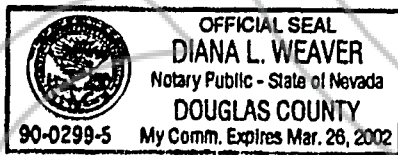
