

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 13th day of May, 1999,

between, RALPH STOKES and MARTHA J. STOKES, Husband and Wife as Joint Tenants, herein called TRUSTOR

and MARQUIS TITLE & ESCROW, INC., a Nevada Corporation, herein called TRUSTEE, and

ROBERT R. COREY and ELIZABETH JEAN COREY, Husband and Wife as Joint Tenants, herein called BENEFICIARY.

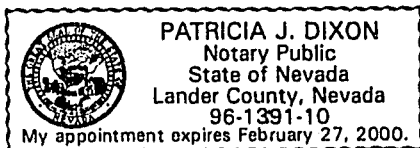
