EXHIBIT "A"
DESCRIPTION

All that certain lot, piece or parcel of land situate in the County of Douglas, State of Nevada, described as follows:

PARCEL I:

Lot 35 as shown on the map of LAKEWOOD KNOLLS SUBDIVISION, DOUGLAS COUNTY, NEVADA, filed in the office of the County Recorder of Douglas County, Nevada, on May 29, 1958, under Document No. 13163.

PARCEL II:

That certain non-exclusive right to egress to and egress from said Lot 35 over that portion of Lot 36 and that portion of Lot 41 in Lakewood Knolls that is described as follows: Beginning at the Southeasterly corner of Lot 41, in said Lakewood Knolls; thence West along the South line of said lot to its Southwest corner; thence North $11^{\circ}11'12''$ East to a point on the North line of lot 36 in said subdivision that is 10.2 feet distant from the Northeast corner thereof; thence South $78^{\circ}21'53''$ East a distance of 60.83 feet to a point that is 10.0 feet Northerly of the South line of said Lot 41 at a right angle thereto; thence Easterly parallel to and 10.0 feet distance from the South line of said lot to a point on its East line; thence Southerly along the East line of said lot to the point of beginning.
