WITNESSETH:



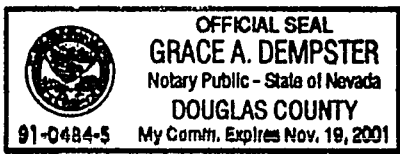
