Beginning at the northeast corner of Lot 5 in Block E of ZEPHYR COVE PROPERTIES in Section 10, Township 13 North, Range 18 East, M.D.B. & M., according to the official amended map of Block E of ZEPHYR COVE PROPERTIES in Section 10, Township 13 North, Range 18 East, M.D.B. & M., filed in the office of the County Recorder of Douglas County, State of Nevada, on August 5, 1935, thence South 47°34' West 118.8 feet on the North line of Lot 5; thence south 0°24' West 100.00 feet between Lots 5 and 6; thence North 64°51' East 106.8 feet; thence North 03°32' West 135 feet between Lots 1 and 5, Block E, to the place of beginning.

EXCEPTING therefrom a perpetual, but not an exclusive, easement for a walk way being 4 feet 4 inches in width along the westerly side of said premises and 4 feet 4 inches in width along the easterly side of said premises, to be reserved unto the grantors, their heirs and assigns, for the purpose of ingress and egress to and from the southerly portion Lot 5 in said Block E.
