WHEREAS, the ADMINISTRATOR, who is the duly elected Public Administrator and Public Guardian of Douglas County, is desirous of retaining ATTORNEY for representation of the ADMINISTRATOR for Fiscal Year 1999-2000 in all matters relating to the provision of legal services and legal support required by the ADMINISTRATOR in the performance of her duties in acting as guardian of indigent wards and the Administrator of indigent estates. ATTORNEY is desirous of serving as legal counsel and legal support to ADMINISTRATOR for all those matters in which counsel is requested by ADMINISTRATOR; and

WHEREAS, ATTORNEY practices in the County, is qualified by experience, and at the time of this Agreement's execution, ATTORNEY is the only practitioner willing to provide this service; and


