ORDER FOR JUDGMENT

17 Upon the Stipulation for Judgment executed by the parties
18 hereto, Plaintiff, SEARS, ROEBUCK AND COMPANY, (hereinafter
19 "Plaintiff"), by and through its attorney, Jeffrey G. Sloane, Esq.
20 of KRAVITZ, SCHNITZER & SLOANE, CHTD., and the Defendant, KATHRYN
21 E. CARLISLE,

22 IT IS HEREBY ORDERED, ADJUDGED AND DECREED that the Plaintiff
23 has Judgment against said Defendant for the sum of \$3,085.83 with
24 interest thereon at the legal rate of 9.75 percent per annum from
25 January 5, 1999, until paid; plus \$833.00 in Attorney's fees and
26 \$175.00 in court costs.

27 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that the
28 aforementioned Judgment shall be paid as follows:

1 On or before the 8th day of July, 1999, Defendant shall pay to
2 Plaintiff Two Hundred Fifty and 00/100 Dollars (\$250.00), then;

3 Commencing on or before the 10th day of August, 1999,
4 Defendant shall pay to Plaintiff Two Hundred Fifty and 00/100
5 Dollars (\$250.00) and a like amount payable on or before the Tenth
6 (10th) of every month thereafter until the full amount of the
7 judgment has been extinguished.

8 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that said payments
9 shall be made payable to KRAVITZ, SCHNITZER & SLOANE, CHTD.,
10 Attention: Noelle Kahn, 2300 W. Sahara Avenue, Suite 500, Las
11 Vegas, Nevada 89102; and shall be received by said offices on or
12 before the aforementioned dates, referencing Account 0056386952107
13 on all payments.

14 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that in the event
15 the Defendant fails, neglects or refuses to pay any such payment on
16 or before its due date, then all sums remaining due under such
17 Judgment shall become due and owing and entry and execution may
18 thereupon issue without benefit of notice to the Defendant.
19 Moreover, in the event that the Defendant fails to timely make any
20 of the aforementioned payments, Plaintiff shall be entitled to make
21 application for legal fees and costs relative to effecting
22 collection and entry of the Judgment.

23 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon payment
24 in full of the amounts aforementioned in the manner provided for
25 herein, Plaintiff shall file a Satisfaction of Judgment.


26 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that upon payment


1 IT IS FURTHER ORDERED, ADJUDGED AND DECREED pursuant to Nevada
