ORDER

15 On September 15, 1997, at 10:00 a.m., this Court  
16 conducted a hearing to have Defendant STEVEN DALE SMITH, show  
17 cause why he should not be held in contempt of court for  
18 failing to pay his court-ordered child support. Gary L.  
19 Kendrick, Deputy District Attorney, appeared on behalf of  
20 Plaintiff KAREN GAYLE SMITH, and Defendant who was in custody  
21 on a Bench Warrant issued August 5, 1997, appeared without  
22 counsel. After hearing the evidence and arguments of the  
23 parties, this Court enters the following findings, order, and  
24 judgment.

FINDINGS

- 25 1. Defendant is the father of STEPHANIE NICOLE SMITH, born 08/18/89, and DALTON GARRETT SMITH, born 02/01/93.
- 26 2. On March 20, 1996, Defendant was ordered to pay  
27 \$300.00 per month per child for a total of \$600.00 per month  
28 as ongoing child support beginning March 1, 1996. Defendant

1 was further ordered to provide health insurance for the  
2 parties' minor children in addition to his ongoing child  
3 support obligation.

4 3. That on November 4, 1996, a hearing was  
5 conducted to have the Defendant show cause why he should not be  
6 held in contempt of court for failing to pay his court ordered  
7 child support. Defendant was found to be capable of paying his  
8 child support and was held in contempt of court for failing to  
9 pay as ordered. The Defendant was sentenced to 10 days in the  
10 Douglas County Jail. The Defendant's 10 day sentence was  
11 suspended upon the condition that the Defendant pay his ongoing  
12 and arrearage payments totaling \$650.00 beginning December 1,  
13 1996, and on the first day of each month thereafter.

14 4. That the Defendant failed to pay his child  
15 support as ordered by this Court on November 13, 1996.

16 5. That since the Court's entry of order on March  
17 20, 1996, Defendant has accrued child support arrearages of  
18 \$4,925.25 through and including September 14, 1997.

19 6. Defendant is employed as an Electrician.

20 7. Defendant is capable of paying his court-ordered  
21 child support.

22 8. Defendant is in contempt of court for failing to  
23 pay his court-ordered child support.

1 IT IS HEREBY ORDERED that Defendant serve an  
2 additional 15 days in the Douglas County Jail for his Contempt  
3 of Court.

4 IT IS FURTHER ORDERED that the full 15 days are  
5 suspended on the condition that Defendant pay the sum of  
6 \$650.00 per month to be applied as follows: \$600.00 as ongoing  
7 child support and \$50.00 toward satisfaction of Defendant's  
8 child support arrearages on or before the first of each month  
9 beginning October 1, 1997.

10 IT IS FURTHER ORDERED that the Defendant be released  
11 from custody and given credit for 6 days time served with 4  
12 days remaining suspended from this Court's previous order of  
13 November 13, 1996. Defendant will therefore have a total of 19  
14 days suspended upon the condition that he make his child  
15 support payments as ordered herein.

16 IT IS FURTHER ORDERED that the Defendant provide the  
17 District Attorney's Office with proof of Defendant's current  
18 income, Defendant's tax return and W-2. Upon a showing of a  
19 substantial change in circumstances warranting a modification  
20 of Defendant's child support obligation, this matter shall be  
21 remanded to the Hearing Master for a formal review. If it is  
22 determined by the District Attorney's Office that no  
23 substantial change of circumstance has occurred, Defendant's  
24 child support obligation shall remain as currently ordered.

25 IT IS FURTHER ORDERED that the Defendant keep the  
26 Douglas County District Attorney's Office informed of  
27 Defendant's change in residence, mailing address, telephone, or  
28 employment within 10 days of any such change.

1 IT IS FURTHER ORDERED that the Defendant provide  
2 health insurance for his minor children.

3 IT IS FINALLY ORDERED that should Defendant fail to  
4 make his \$650.00 per month ongoing child support and arrearage  
5 payment by the first day of every month, a bench warrant shall  
6 immediately be issued.

7  
8 **JUDGMENT**

9 Judgment is hereby entered in favor of Plaintiff and  
10 against Defendant in the amount of \$4,925.25 through September  
11 14, 1997.
