> AGREEMENT AND STIPULATION RE MOTION TO AVOID LIEN IMPAIRING DEBTOR'S EXEMPTIONS

2. On April 12, 1994, a judgment was recorded in favor of
creditor against debtor from a judgment in the First Judicial

Case Number 94-00279A which created a lien on the real property

was recorded in favor of creditor against debtor from a
judgment in the Justice Court of East Fork Township County of
