ASSIGNMENT OF PROMISSORY NOTE AND ASSIGNEE'S INTEREST

THIS ASSIGNMENT, made and entered into this 1<sup>st</sup> day of September, 1999, by and between RUDOLPH S. GERSICK and GERTRUDE A. GERSICK, Trustees of the RUDOLPH S. GERSICK AND GERTRUDE A. GERSICK INTER VIVOS TRUST, U/T/A dated October 29, 1973 and as reformed and restated on April 5, 1998, hereinafter referred to as "Assignors" and RGG ENTERPRISES LIMITED PARTNERSHIP, a Nevada limited partnership, hereinafter referred to as "Assignee."

W I T N E S S E T H:

WHEREAS, on January 17, 1997, Stephen Camara and Cindy Camara, husband and wife, did make and execute a Promissory Note in favor of Michael Bray and Judith Bray, husband and wife, hereinafter referred to as the "Camara Note," in the face amount of one hundred and fifty thousand dollars (\$150,000);

WHEREAS, Michael Bray and Judith Bray are the payee of the Camara Note which is secured by a Deed of Trust, hereinafter referred to as the "Camara Deed of Trust," made between Stephen Camara and Cindy Camara as Trustor and Marquis Title & Escrow, Inc., a Nevada corporation, as Trustee, dated January 17, 1997,

and recorded as Instrument #405094, in the records of Douglas County, Nevada;

WHEREAS, on February 11, 1997, Michael Bray and Judith Bray, husband and wife, did make and execute a Promissory Note, hereinafter referred to as the "Bray Note," in favor of Assignors in the amount of one hundred and seven thousand dollars (\$107,000);

WHEREAS, Assignors are the payee of the Bray Note which is secured by (1) a Partial Collateral Assignment of Proceeds of Note Agreement dated February 11, 1997, wherein Michael Bray and Judith Bray as assignors have assigned to Assignors herein a partial interest in the monthly payments pursuant to the Camera Note and (2) a Collateral Assignment of Deed of Trust, dated February 11, 1997, wherein Michael Bray and Judith Bray as assignors have assigned to Assignors herein a partial interest as beneficiary of the Camera Deed of Trust, and said Collateral Assignment is recorded as Instrument # 0407080, in the records of Douglas County; and

WHEREAS, Assignors desire to assign all of their right, title and interest in and to the Camera Note, the Camera Deed of Trust and the Bray Note.
