SUBSTITUTION OF TRUSTEE  
AND RECONVEYANCE

THIS SUBSTITUTION OF TRUSTEE AND RECONVEYANCE is entered into this 7TH day of SEPTEMBER, 1999, by and between AMERICAN SECURITIES COMPANY OF NEVADA (Successor Trustee), and WELLS FARGO BANK, N. A. (Successor Beneficiary).

Whereas, UNITED ELECTRICAL SERVICES, INC., A NEVADA CORPORATION, executed that certain PROMISSORY NOTE dated DECEMBER 20, 1994, in the amount of ONE HUNDRED FORTY-FIVE THOUSAND SEVEN HUNDRED FIFTY AND 00/100 Dollars (\$145,750.00) in favor of FIRST INTERSTATE BANK OF NEVADA, N.A. WHEREAS, Successor Beneficiary desires to appoint Successor Trustee to act as trustee in place of Original Trustee named in the Deed of Trust, and to request Successor Trustee to reconvey to all persons legally entitled thereto all of the right, title and interest granted to Original Trustee by the Deed of Trust.

NOW THEREFORE, Successor Trustee and Successor Beneficiary agree as follows:


1. Successor Beneficiary, pursuant to California Civil Code Section 2934A, appoints Successor Trustee to act as trustee in place of Original Trustee named in the Deed of Trust.

2. Successor Trustee does hereby quitclaim and reconvey unto the person or persons legally entitled thereto, without any warranty, all of the right, title and interest granted to Original Trustee by the Deed of Trust in the real property described therein, reference being hereby specifically made to the Deed of Trust and the record thereof for a particular description of said real property. This reconveyance is executed at the request of Successor Beneficiary.

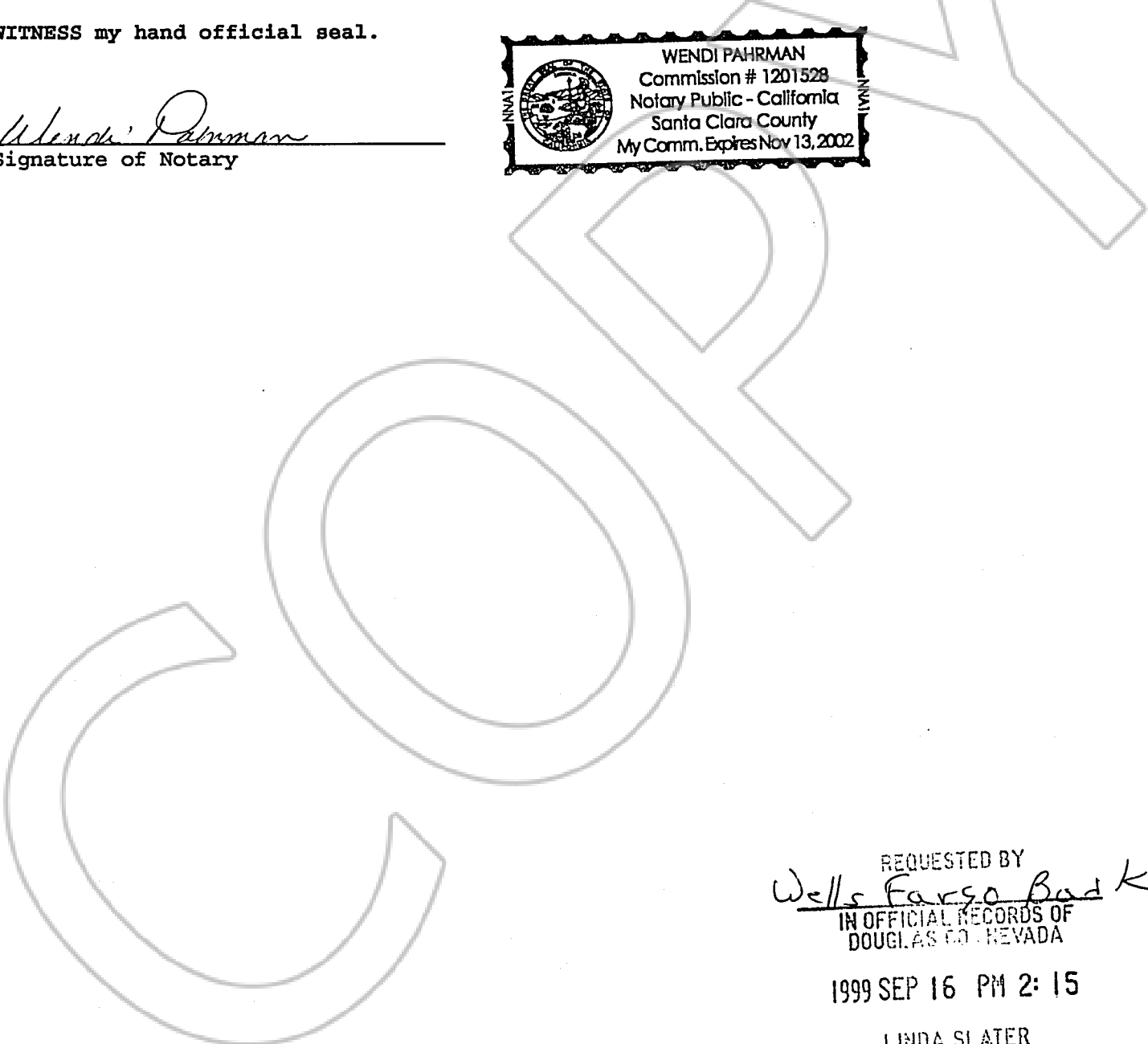
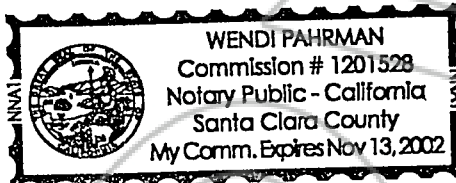
