- 1. On April 1, 1987, Ernst Kahn and Marjorie Ingeborg Kahn as Trustors/Settlors and Trustees executed The Ernst Kahn And Marjorie Ingeborg Kahn Inter Vivos Trust ("The Kahn Family Trust dated 04/01/87 or The 04/01/87 Kahn Family Trust").
- 2. A. Pursuant to Article 10, Section 10.1 of The Kahn Family Trust dated 04/01/87:
 - (1) upon the death of Trustee Marjorie Ingeborg
 Kahn, Robert Martin was nominated to act as
 Successor Trustee to Marjorie Ingeborg Kahn;
 and,
 - (2) upon the death of Ernst Kahn, Robert Martin as nominated to act as Successor Trustee to Ernst Kahn.
 - B. A copy of the first page and pages 41, 42, 43, 44, 45, 46 and 47 of The Kahn Family Trust dated 04/01/87 is attached hereto as Exhibit A and made a part hereof.
- 3. On December 10, 1988, Marjorie Ingeborg Kahn became deceased.
- 4. On February 22, 1989, Ernst Kahn (the surviving Trustor/Settlor and Trustee of The Kahn Family Trust dated 04/01/87) executed 3 Affidavits regarding Declaration Of Trustees, with attached:
 - (1) certified copy of Certificate Of Death of Marjorie 0477103

Ingeborg Kahn,

(2) the first page and pages 41, 42, 43, 46 and 47 of The Kahn Family Trust dated 04/01/87, and

(3) Robert Martin's Affidavit Of Successor Trustee evidencing Robert Martin's acceptance of appointment as Successor Trustee to decedent Marjorie Ingeborg Kahn.

Said Affidavits regarding Declaration Of Trustees were recorded as follows:

- (1) in official records of Washoe County, Nevada, Recorder's Office on February 23, 1989 in book 2870 at page 0158 as document no. 1306531;

 - 6. The Survivor's Trust was amended by the:
 - (1) January 15, 1993 First Amendment To The Survivor's Trust Under Declaration Of The Kahn Family Trust dated 04/01/87 ("First Amendment");
 - (2) February 13, 1995 Second Amendment To The Survivor's Trust Under Declaration Of The Kahn Family Trust dated 04/01/87 ("Second Amendment");
 - (3) September 9, 1996 Third Amendment To The Survivor's Trust Under Declaration Of The Kahn Family Trust dated 04/01/87 ("Third Amendment"); and,
 - (4) June 18, 1998 Fourth Amendment To The Survivor's Trust Under Declaration Of The Kahn Family Trust dated 04/01/87 ("Fourth Amendment"). The Fourth Amended superseded and totally amended the First Amendment, Second Amendment and Third Amendment.
 - 7. The Survivor's Trust has never been revoked.
- 8. Until the death of Ernst Kahn, Robert Martin acted as a Co-Trustee of The Survivor's Trust.
- 9. Ernst Kahn became deceased on March 10, 1999. A certified copy of Certificate Of Death of Ernst Kahn is attached hereto as Exhibit B and made a part hereof.
 - 10. A. Upon the death of the surviving spouse, i.e., Ernst Kahn:

- (1) Robert Martin was appointed to act as the independent Trustee of the Survivor's Trust under The Kahn Family Trust dated 04/01/87; said appointment of Robert Martin as the independent Trustee of the Survivor's Trust was reaffirmed in the June 18, 1998 Fourth Amendment To The Survivor's Trust; and
- B. Pursuant to the June 18, 1998 Fourth Amendment To The Survivor's Trust:
 - (1) Vivian Adele Kahn Morgan and Robert Joseph Kahn were appointed to act as Co-Trustees, with independent Trustee Robert Martin, of the Survivor's Trust.
- C. A copy of the pages 1, 12, 13, 14, 15 and 16 of the June 18, 1998 Fourth Amendment To The Survivor's Trust is attached hereto as Exhibit C and made a part hereof.

ERNST KAHN AND MARJORIE INGEBORG KAHN INTER VIVOS TRUST AGREEMENT

THIS INTER VIVOS TRUST AGREEMENT is entered into by Ernst Kahn and Harjorie Ingeborg Kahn as Trustors (and 🕏 also referred to herein as the "Settlors" and as "Musband" and "Wife", depending on the context), and Ernst Kahn and Marjorie Ingeborg Kahn as Trustees (hereinafter "Trustee"), and they declare that they have set aside, as Settlors, and hold in trust, as the Trustee, the sum of One Hundred (\$100.00) Dollars; and, that in addition, Wife intends to and will designate this Trust as beneficiary of such life insurance policies on Husband's life as are owned by her as her separate property, and Husband intende to and will designate this Trust as beneficiary of such ·life insurance policies on Wife's life as are owned by him as his separate property. In addition, other property acceptable to the Trustee may be added to this Trust by any person, by the Will or Codicil of the Settlors, by the proceeds of any life insurance or otherwise.

ARTICLE 1

TRANSFERS INTO TRUST

1.1 Character of property remains unchanged.

property subject to this instrument is referred to as the "trust estate". Any separate property of either Settlor which is transferred to this Trust and becomes part of the trust estate shall be held, administered and

ARTICLE 10

TRUSTEE PROVISIONS

10.1 Sucessor Trustees.

If Ernst Kahn shall for any reason cease to act as

Trustee during the Settlors' joint lifetimes, then Marjorie

Ingeborg Kahn shall act as Trustee in said Settlor's place; if

Marjorie Ingeborg Kahn shall for any reason cease to act as

Trustee during the Settlors' joint lifetimes, then Ernst Kahn

shall act as Trustee in said Settlor's place.

In the event that Ernst Kahn would be the first Trustor to die, then concurrently with such death, Robert Martin shall become Co-Trustee with Marjorie Ingeborg Kahn. Should Marjorie Ingeborg Kahn be incompetent or otherwise unwilling or unable to act, then Robert Martin shall become the independent Trustee. In the event of the death, incompetency, inability or unwillingness of Robert Martin to act as independent Trustee, then Sonner Greenspan shall act as the independent Trustee of the trusts herein created.

In the event Marjorie Ingeborg Kahn should be the first Trustor to die, then concurrently with such death, Robert Martin shall become Co-Trustee with Ernst Kahn. Should Ernst Kahn be incompetent or otherwise unwilling or unable to act, ther Robert Martin shall become the independent Trustee. In the event of the death, incompetency, inability or unwillingness of Robert Martin to act as independent Trustee,

then Sonner Greenspan shall act as the independent Trustee of the trusts herein created.

of both the Trustors to act, then Robert Martin shall become the independent Trustee of the trusts herein created. In the event of the death, incompetency, inability or unwillingness of Robert Martin to act, then Sonner Greenspan shall become the independent Trustee of the trusts herein created.

All discretionary invasions of principal made by the Trustee in favor of the Surviving Spouse shall be determined by the independent Trustee alone.

10.2 Trustees may appoint successor Trustees.

Notwithstanding the last preceding Paragraph 10.1, each person designated or acting from time to time as a Trustee of any Trust established by this Trust Agreement shall have the power at any time, to designate successor Trustees to act when he or she shall become unable or unwilling to act as Trustee of any Trust. Each such person may designate the same or different persons or entities, including corporate fiduciaries, to act as successor Trustee of any Trust. Any such person acting as Trustee of any Trust may from time to time revoke any designation of any successor to himself (whether that designation shall have been made by him or by his antecedent in interest), and that person may designate other persons or entities, or one or more or the same persons or entities or all the same persons or entities previously designated in a different order, as successor Trustee to him. All such

shall be effective on delivery to the beneficiaries of any trust for which it is designated. Also, each individual Co-Trustee may replace any successor corporate Co-Trustee with another corporate Trustee or with an individual Co-Trustee, provided that if an individual Trustee has the right to receive the principal of any Trust created herein as a result of a discretionary invasion of principal, said Trustee shall either appoint a corporate Trustee as Co-Trustee, or shall appoint an individual Trustee as Co-Trustee who has "a substantial interest in the property which is adverse" to that of the remaining Trustee, as defined in Section 2014(b)(1)(C)(ii) of the Internal Revenue Code of 1954 as amended from time to time and the United States Treasury Regulations applicable thereto.

ARTICLE 11

REVOCATION AND AMENDMENT

11.1 Revocation.

During the joint lifetimes of the Settlors, this Trust may be revoked in whole or in part with respect to community property by an instrument in writing signed by either Settlor and delivered to the other Settlor, and the Trustee, if said Trustee is someone other than either Settlor, and with respect to separate property by an instrument in writing signed by the Settlor who contributed that property to this Trust, delivered to the other Settlor if said other Settlor is a Trustee; otherwise, it should be delivered to the Trustee. On revocation, the Trustee shall promptly deliver to both Settlors

assets. All property delivered to both Settlors shall continue to be the Settlors' community property. On revocation with respect to separate property, the Trustee shall promptly deliver to the contributing Settlor all or the designated portion of that property, and all such delivered property shall continue to be the separate property of the contributing Settlor. If this instrument is revoked with respect to all or a major portion of the assets subject to this instrument, the Trustee shall be entitled to retain sufficient assets reasonably to secure payment of liabilities lawfully incurred by the Trustee in the administration of this Trust including Trustee's fees that have been earned, unless the Settlors shall indemnify the Trustee against loss or expense.

11.2 Life insurance.

Only the Wife shall have the power to revoke or amend this Trust with respect to any policy of insurance or its proceeds on the life of the Husband owned by the Wife as her separate property, and she shall have that power only during the Husband's lifetime. With respect to such insurance, any revocation or amendment made by the Musband at any time shall have no effect and shall not be taken into account. Only the Musband shall have the power to revoke or amend this Trust with respect to any policy of insurance or its proceeds on the life of the Wife owned by the Husband as his separate property, and he shall have that power only during the Wife's lifetime. With respect to such insurance, any revocation or amendment made by

the Wife at any time shall have no effect and shall not be taken into account.

11.3 Amendment by both Settlors.

Except as provided in Pargraphs 8.3 and 11.2, the

Settlors may at any time during their joint lifetimes amend any
of the terms of this instrument by an instrument in writing

signed by both Settlors.

11.4 Amendment by Surviving Spouse.

On the death of the Deceased Spouse, the Surviving Spouse shall have the power to amend, revoke, or terminate the Survivor's Trust, but the Bypass Trust (if any) may not be amended, revoked or terminated. On the death of the Surviving Spouse, none of the Trusts may be amended, revoked, or terminated. On revocation or termination of the Survivor's Trust, all its assets shall be delivered to the Surviving Spouse.

11.5 Amendment powers are personal to Settlors.

The powers of the Settlors to revoke or amend this instrument are personal to them and shall not be exercisable in or on their behalf by any guardian, conservator, or other person, except that revocation or amendment may be authorized, after notice to the Trustee by the court that appointed the guardian or conservator.

ARTICLE 12

TRUST NAME

As used in this Trust Agreement, the term "this Trust" shall reter collectively to all Trusts created in this Trust

Agreement. Such Trusts may be referred to collectively as the "KAHN FAMILY TRUST" and each separate trust created in this instrument may be referred to by adding the name of the beneficiary.



Whereas, Ernst Kahn and Marjorie Ingeborg Kahn, as Settlors and Trustees, executed the Ernst Kahn and Marjorie Ingeborg Kahn Inter Vivos Trust on April 1, 1987 (sometimes referred to as the Kahn Family Trust); and,

Whereas, on December 10, 1988, Marjorie Ingeborg Kahn became deceased; and,

Whereas, pursuant to the provisions of the Kahn Family Trust, upon the death of Marjorie Ingeborg Kahn, Robert Martin became the Successor Trustee to Marjorie Ingeborg Kahn; and,

Whereas, pursuant to the provisions of the Kahn Family Trust, upon the death of Marjorie Ingeborg Kahn, the Kahn Family Trust estate assets were divided into the Survivor's Trust and the Residual Trust (sometimes referred to as the Bypass Trust or Exemption Equivalent Trust); and,

Whereas, Ernst Kahn, on the 27th day of January, 1993, executed a First Amendment To The Survivor's Trust Under Declaration Of The Ernst Kahn And Marjorie Ingeborg Kahn Inter Vivos Trust (sometimes referred to as the First Amendment); and,

Trustee or Grantor at death, or income of the Trust to be included in the income tax returns of the Trustee or Grantors.

Any right, power, duty or discretion with such effect shall be null and void with respect to said Trustee or Grantors."

14. ARTICLE 10 entitled <u>TRUSTEE PROVISIONS</u> of the Kahn Family Trust and the First Amendment and the Second Amendment shall be, and hereby is, amended and changed in total to read as follows:

"ARTICLE 10

10.1 <u>Successor Trustees</u>.

- A. If, during his lifetime, Ernst Kahn shall for any reason cease to act as Trustee, be incompetent or otherwise unwilling or unable to act as Trustee of the Survivor's Trust Portion of the Kahn Family Trust, then Robert Martin shall act as independent Trustee and Vivian Adele Kahn and Robert Joseph Kahn shall act as Co-Trustees with the independent Trustee of the Survivor's Trust Portion of the Kahn Family Trust.
- B. Upon the death of Ernst Kahn, Robert Martin shall become act as the independent Trustee and Vivian Adele Kahn and Robert Joseph Kahn shall become a Co-Trustee with the independent Trustee of the Survivor's Trust Portion of the Kahn Family Trust.
- C. In the event of the death, incompetency, inability or unwillingness of Robert Martin to act as the independent Trustee of the Survivor's Trust Portion of the Kahn Family Trust, then Gerald L. Morgan shall act as the independent Trustee in the place and stead of Robert Martin. In the event of the death, incompetency, inability or unwillingness of Oli 77103

- Gerald L. Morgan to act as independent Trustee of the Survivor's Trust Portion of the Kahn Family Trust, then Mark Elston shall act as the independent Trustee of the Survivor's Trust Portion of the Kahn Family Trust.
- D. All discretionary invasions of principal made by the Trustee in favor of the Surviving Spouse shall be determined by the independent Trustee alone.
- E. It is the request of Ernst Kahn, but not the direction of Ernst Kahn, that Robert Martin and/or Sonner Greenspan or any successor independent Trustee of the Bypass Trust Portion of the Kahn Family Trust consult with Vivian Adele Morgan and Robert Joseph Kahn regarding Trustee decisions.
- F. It is the request of Ernst Kahn, but not the direction of Ernst Kahn, that should Robert Martin or Sonner Greenspan be unable or unwilling for any reason whatsoever to act as independent Trustee of the Bypass Trust Portion of the Kahn Family Trust, Robert Martin or Sonner Greenspan nominate and appoint Gerald L. Morgan to act as the independent Trustee of the Bypass Trust Portion of the Kahn Family Trust. In the event of the death, incompetency, inability or unwillingness of Gerald L. Morgan to act as independent Trustee of the Bypass Trust Portion of the Kahn Family Trust, then it is the request of Ernst Kahn, but not the direction of Ernst Kahn, that Robert Martin or Sonner Greenspan nominate and appoint Mark Elston to act as the independent Trustee of the Bypass Trust Portion of the Kahn Family Trust.

10.2 Trustees may appoint successor Trustees.

Notwithstanding the last preceding Paragraph 10.1, each person designated or acting from time to time as a Trustee of any Trust established by this Trust Agreement shall have the power at any time, to designate successor Trustees to act when he or she shall become unable or unwilling to act as Trustee of any Trust. Each such person may designate the same or persons or entities, including corporate fiduciaries, to act as successor Trustee of any Trust. Any such person acting as Trustee of any Trust may from time to time revoke any designation of any successor to himself (whether that designation shall have been made by him or by his antecedent in interest), and that person may designate other persons or entities, or one or more of the same persons or entities or all the same persons or entities previously designated in a different order, as successor Trustee to him. All such designations or revocations shall be exercised in writing and shall be effective on delivery to the beneficiaries of any trust for Which it is designated. Also, each individual Co-Trustee may replace any successor corporate Co-Trustee with another corporate Trustee or with individual Co-Trustee, provided that if an individual Trustee has the right to receive the principal of any Trust created herein as a result of a discretionary invasion of principal, said Trustee shall either appoint a corporate Trustee as Co Trustee, or shall appoint an individual Trustee as Co Trustee who has "a substantial interest in the property which is adverse" to that of the remaining Trustee, as defined

15. <u>ARTICLE 13</u>, entitled <u>APPOINTMENT OF GUARDIAN</u>, as set forth hereinbelow, is hereby added to the Survivor's Trust Portion of the Kahn Family Trust, i.e.:

"ARTICLE 13

APPOINTMENT OF GUARDIAN

In the event it becomes necessary to appoint a guardian or conservator for me, as an individual, then I nominate and appoint VIVIAN ADELE MORGAN and ROBERT JOSEPH KAHN as such coguardians or co-conservators. Neither of the above named individuals shall be required to furnish bond in any jurisdiction for acting as such guardian or conservator."

16. Any and all reference to the Internal Revenue Code of 1954 in the Kahn Family Trust dated April 1, 1987, and any and all other documents related thereto, shall be and hereby is deemed to mean the Internal Revenue Code of 1986.
