- 1. On April 1, 1987, Ernst Kahn and Marjorie Ingeborg Kahn as Trustors/Settlors and Trustees executed The Ernst Kahn And Marjorie Ingeborg Kahn Inter Vivos Trust ("The Kahn Family Trust dated 04/01/87 or The 04/01/87 Kahn Family Trust").
- 2. A. Pursuant to Article 10, Section 10.1 of The Kahn Family Trust dated 04/01/87:
 - (1) upon the death of Trustee Marjorie Ingeborg Kahn, I was nominated to act as Successor Trustee to Marjorie Ingeborg Kahn; and,
 - (2) upon the death of Ernst Kahn, I was nominated to act as Successor Trustee to Ernst Kahn;
 - (3) upon the death of both Marjorie Ingeborg Kahn and Ernst Kahn, I was nominated to act as the independent Trustee ("Trustee");
 - B. A copy of the first page and pages 41, 42, 43, 44, 45, 46 and 47 of The Kahn Family Trust dated 04/01/87 is attached hereto as Exhibit A and made a part hereof.
- 3. On December 10, 1988, Marjorie Ingeborg Kahn became deceased; and, I accepted the appointment to act as Successor Trustee to deceased Trustee Marjorie Ingeborg Kahn.
- 4. On February 22, 1989, Ernst Kahn (the surviving Trustor/Settlor and Trustee of The Kahn Family Trust dated 04/01/87) executed 3 Affidavits regarding Declaration Of Trustees, with attached:
 - (1) certified copy of Certificate Of Death of Marjorie Ingeborg Kahn,
 - (2) the first page and pages 41, 42, 43, 46 and 47 of The Kahn Family Trust dated 04/01/87, and

my Affidavit Of Successor Trustee evidencing my (3) acceptance of appointment as Successor Trustee to decedent Marjorie Ingeborg Kahn.

ERNST KAHN AND MARJORIE INGEBORG KAHN INTER VIVOS TRUST AGREEMENT

THIS INTER VIVOS TRUST AGREEMENT is entered into by Ernst Kahn and Marjorie Ingeborg Kahn as Trustors (and also referred to herein as the "Settlors" and as "Busband and "Wife", depending on the context), and Ernst Kahn am Marjorie Ingeborg Kahn as Trustees (hereinafter "Trusteo"), and they declare that they have set aside, Settlors, and hold in trust, as the Trustee, the sum of One Hundred (\$100.00) Pollars; and, that in addition, Wife intends to and will designate this Trust as beneficiary of such life insurance policies on Husband's life as are owned by her as her separate property, and Husband intend to and will designate this Trust as beneficiary of such ·life insurance policies on Wife's life as are owned by him as his separate property. In addition, other property acceptable to the Trustee may be added to this Trust by any person, by the Will or Codicil of the Settlors, by the proceeds of any life insurance or otherwise.

ARTICLE 1

TRANSFERS INTO TRUST

1.1 Character of property remains unchanged.

ARTICLE 10

TRUSTEE PROVISIONS

10.1 Sucessor Trustees.

If Ernst Kahn shall for any reason cease to act as
Trustee during the Settlors' joint lifetimes, then Marjorie
Ingeborg Kahn shall act as Trustee in said Settlor's place; if
Marjorie Ingeborg Kahn shall for any reason cease to act as
Trustee during the Settlors' joint lifetimes, then Ernst Kahn
shall act as Trustee in said Settlor's place.

In the event that Ernst Kahn would be the first Trustor to die, then concurrently with such death, Robert Martin shall become Co-Trustee with Marjorie Ingeborg Kahn. Should Marjorie Ingeborg Kahn be incompetent or otherwise unwilling or unable to act, then Robert Martin shall become the independent Trustee. In the event of the death, incompetency, inability or unwillingness of Robert Martin to act as independent Trustee, then Sonner Greenspan shall act as the independent Trustee of the trusts herein created.

In the event Marjorie Ingeborg Kahn should be the first Trustor to die, then concurrently with such death, Robert Martir shall become Co-Trustee with Ernst Kahn. Should Ernst Kahn be incompetent or otherwise unwilling or unable to act, ther Robert Martin shall become the independent Trustee. In the event of the death, incompetency, inability or unwillingness of Robert Martin to act as independent Trustee,

then Sonner Greenspan shall act as the independent Trustee of the trusts herein created.

Upon the death, incompetency, inability or unwillingness of both the Trustors to act, then Robert Martin shall become the independent Trustee of the trusts herein created. In the event of the death, incompetency, inability or unwillingness of Robert Martin to act, then Sonner Greenspan shall become the independent Trustee of the trusts herein created.

All discretionary invasions of principal made by the Trustee in favor of the Surviving Spouse shall be determined by the independent Trustee alone.

10.2 Trustees may appoint successor Trustees.

Notwithstanding the last preceding Paragraph 10.1, each person designated or acting from time to time as a Trustee of any Trust established by this Trust Agreement shall have the power at any time, to designate successor Trustees to act when he or she shall become unable or unwilling to act as Trustee of any Trust. Each such person may designate the same or different persons or entities, including corporate fiduciaries, to act as successor Trustee of any Trust. Any such person acting as Trustee of any Trust may from time to time revoke any designation of any successor to himself (whether that designation shall have been made by him or by his antecedent in interest), and that person may designate other persons or entities, or one or more of the same persons or entities or all the same persons or entities previously designated in a different order, as successor Trustee to him. All such

designations or revocations shall be exercised in writing and shall be effective on delivery to the beneficiaries of any trust for which it is designated. Also, each individual Co-Trustee may replace any successor corporate Co-Trustee with another corporate Trustee or with an individual Co-Trustee, provided that if an individual Trustee has the right to receive the principal of any Trust created herein as a result of a discretionary invasion of principal, said Trustee shall either appoint a corporate Trustee as Co-Trustee, or shall appoint an individual Trustee as Co-Trustee who has "a substantial interest in the property which is adverse" to that of the remaining Trustee, as defined in Section 2014(b)(1)(C)(ii) of the Internal Revenue Code of 1954 as amended from time to time and the United States Treasury Regulations applicable thereto.

ARTICLE 11

REVOCATION AND AMENDMENT

11.1 Revocation.

may be revoked in whole or in part with respect to community property by an instrument in writing signed by either Settlor and delivered to the other Settlor, and the Trustee, if said Trustee is someone other than either Settlor, and with respect to separate property by an instrument in writing signed by the Settlor who contributed that property to this Trust, delivered to the other Settlor if said other Settlor is a Trustee; otherwise, it should be delivered to the Trustee. On revocation, the Trustee shall promptly deliver to both Settlors

assets. All property delivered to both Settlors shall continue to be the Settlors' community property. On revocation with respect to separate property, the Trustee shall promptly deliver to the contributing Settlor all or the designated portion of that property, and all such delivered property shall continue to be the separate property of the contributing Settlor. If this instrument is revoked with respect to all or a major portion of the assets subject to this instrument, the Trustee shall be entitled to retain sufficient assets reasonably to secure payment of liabilities lawfully incurred by the Trustee in the administration of this Trust including Trustee's fees that have been earned, unless the Settlers shall indemnify the Trustee against loss or expense.

11.2 Life insurance.

Only the Wife shall have the power to revoke or amend this Trust with respect to any policy of insurance or its proceeds on the life of the Husband owned by the Wife as her separate property, and she shall have that power only during the Husband's lifetime. With respect to such insurance, any revocation or amendment made by the Husband at any time shall have no effect and shall not be taken into account. Only the Husband shall have the power to revoke or amend this Trust with respect to any policy of insurance or its proceeds on the life of the Wife owned by the Husband as his separate property, and he shall have that power only during the Wife's lifetime. With respect to such insurance, any revocation or amendment made by

the Wife at any time shall have no effect and shall not be taken into account.

11.3 Amendment by both Settiors.

Except as provided in Pargraphs 8.3 and 11.2, the

Settlors may at any time during their joint lifetimes amend any
of the terms of this instrument by an instrument in writing

signed by both Settlors.

11.4 Amendment by Surviving Spouse.

On the death of the Deceased Spouse, the Surviving Spouse shall have the power to amend, revoke, or terminate the Survivor's Trust, but the Bypass Trust (if any) may not be amended, revoked or terminated. On the death of the Surviving Spouse, none of the Trusts may be amended, revoked, or terminated. On revocation or termination of the Survivor's Trust, all its assets shall be delivered to the Surviving Spouse.

11.5 Amendment powers are personal to Settlors.

The powers of the Settlors to revoke or amend this instrument are personal to them and shall not be exercisable in or on their behalf by any guardian, conservator, or other person, except that revocation or amendment may be authorized, after notice to the Trustee by the court that appointed the guardian or conservator.

ARTICLE 12

TRUST NAME

As used in this Trust Agreement, the term "this Trust" shall reter collectively to all Trusts created in this Trust

Agreement. Such Trusts may be referred to collectively as the "KAHN FAMILY TRUST" and each separate trust created in this instrument may be referred to by adding the name of the beneficiary.
