2. A Notice of Sale was published in the manner required by N.R.S. 148.220. An Affidavit of Publication was previously filed with the Court.

3. The real property sold is commonly described as 655, 657, and 659 Joette Drive, Gardnerville, Douglas County, Nevada. The legal description of the real property is:

Lots 50, 51 and 52, as shown on the map of GARDNERVILLE RANCHOS UNIT NO. 7, filed for record in the office of the County Recorder of Douglas County, Nevada, on March 27, 1974, as Document No. 72456.

Assessment Parcel No. 0000-29-293-280, 000029-283-130, and 00029-283-140

The real property being sold includes all tenements, hereditaments and appurtenances of the real property, the rents, issues and profits thereof. The real property was appraised at \$35,000.00.

4. The offer as set forth in the Land Purchase Agreement in the amount of \$33,000.00 for each parcel is less than the appraised value, but because no real estate brokerage commission is to be paid on the sale, the sales price of \$33,000.00 for each parcel is approximately equal to what the estate would realize if the real property were sold at its appraised value, less a brokerage commission. Petitioner is ordered to complete the sale in accordance 2. with the terms described herein and the additional terms described in the Land Purchase Agreements, copies of which are attached to the Return of Sale and Petition for Confirmation of Sale of Real Property as Exhibit "A".

Upon the close of escrow for the sale, the co-executrixes 3. of the ESTATE OF LOUIS BUSTANHOBY, Deceased, shall execute and deliver to West Ridge Homes, Inc., a deed conveying all of the right, title and interest of the ESTATE OF LOUIS BUSTANHOBY, Deceased, in the real property.
