BILL OF SALE AND ASSIGNMENT

THIS BILL OF SALE AND ASSIGNMENT is made and entered into this **24L** day of **October**, 1999, by and among GILBERT CARREAU ("Carreau") and SPECTRUM RESOURCES TOWERS, L.P., a Delaware limited partnership ("Spectrum").

 - 2. ACCEPTANCE. Spectrum hereby accepts the foregoing sale and assignment.
- 3. WARRANTY OF TITLE. Carreau warrants that Carreau has good and marketable title to the Tower, free from any and all liens (as defined in the Letter Agreement) except for current personal property taxes not yet due and payable.
- 4. THE LETTER AGREEMENT. This Bill of Sale and Assignment is subject in all respects to the terms and conditions of the Letter Agreement. Nothing contained in this Bill of Sale and Assignment shall be deemed to supersede any of the covenants, agreements, representations or warranties of Carreau or Spectrum contained in the Letter Agreement.
