NOTICE OF DEFAULT AND ELECTION TO SELL UNDER DEED OF TRUST

CASTRO, HUSBAND AND WIFE, as Trustor, to secure obligations in favor of COMMERCE SECURITY BANK, ITS SUCCESSORS AND/OR ASSIGNS A California Corporation as beneficiary, recorded on September 21, 1995 as Instrument No. 370944, Book No. 0995, Page No. 3317, of Official Records in the office of the Recorder of DOUGLAS County, Nevada. There is now owing and unpaid upon said note the sum of \$119,788.24 principal, with interest thereon from August 1, 1999.
