

SHORT FORM DEED OF TRUST AND ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made this 15 day of DECEMBER, 1999,

between, JAMES D. CORE AND MARY J. CORE, TRUSTEES OF THE CORE FAMILY TRUST DATED 9/20/90
herein called TRUSTOR

whose address is P.O. BOX 633, MAMMOTH LAKES, CA. 93546

and MARQUIS TITLE & ESCROW, INC., a Nevada Corporation, herein called TRUSTEE, and

DEN-MAR ASSOCIATES, LIMITED LIABILITY COMPANY 2/12/96, herein called BENEFICIARY.

WITNESSETH: That Trustor irrevocable grants, transfers and assigns to Trustee in trust, with power of sale, that property in DOUGLAS, State of Nevada, being Assessment Parcel No. 23-482-26, more specifically described as follows:

PARCEL 10-B-1, AS SET FORTH ON THAT CERTAIN PARCEL MAP NO. LDA97-077 FOR DEN-MAR ASSOCIATES, FILED FOR RECORD IN THE OFFICE OF THE COUNTY RECORDER OF DOUGLAS COUNTY, STATE OF NEVADA, ON MARCH 20, 1998, BOOK 398, PAGE 4640, DOCUMENT NO. 435441.

THIS DEED OF TRUST CONTAINS A PREPAYMENT PENALTY OF 20% OF THE ENTIRE PRINCIPAL BALANCE IF ANY PRINCIPAL PAYMENT IS MADE PRIOR TO JANUARY 10, 2005.

Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Beneficiary to collect and apply such rents, issues and profits.


For the purpose of securing (1) payment of the sum of \$ 60,000.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidence by a promissory note or notes reciting that they are secured by this Deed of Trust.

To protect the security of this Deed of Trust, and with respect to the property above described, Trustor expressly makes each and all of the agreements, and adopts and agrees to perform and be bound by each and all of the terms and provisions set forth in subdivision A, and it is mutually agreed that each and all of the terms and provisions set forth in subdivision B of the fictitious Deed of Trust recorded in the office of each County Recorder in the State of Nevada, in the book and at the page thereof, or under the document file number, noted below opposite the name of such county, namely:



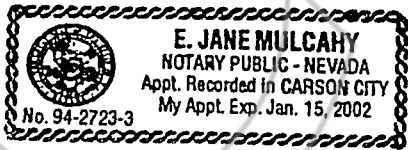


