

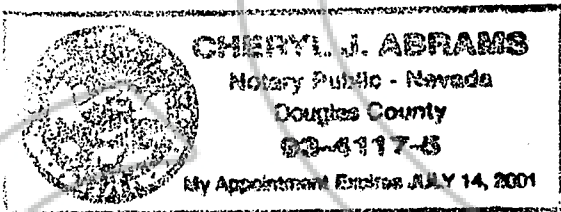

11 4. () That the order of support sought to be enforced
12 is valid and there is no fraud or mistake of fact;

13 5. That the order of support sought to be enforced is not
14 valid and/or there is fraud or mistake of fact as follows:

15 () The Court which issued the order for support
16 lacked personal jurisdiction over the Respondent/Obligor;

17 () That there was a mistake of fact as to whether
18 the responsible parent has been delinquent in the payment of
19 support;

20 (✓) That there was a mistake of fact as to the amount
21 of the arrearages or support;

22 () That there was a mistake of fact as to the

24 () That the order of support was obtained by fraud.

25 IT IS FURTHER FOUND THAT: The order entered
26 in Case No. DV 94-00326 And Jud. Dist CT
27 contains a clerical error - it involves 2
28 minor children D's Gmt was \$/680 AND
75% of that is \$480, NOT \$487

IT IS HEREBY RECOMMENDED THAT:

1
2 1. (Respondent/Obligor shall pay child support and
3 arrearages by immediate wage withholding. **THIS IS AN INCOME**
4 **WITHHOLDING ORDER.** A mandatory wage withholding shall be
5 initiated against the Respondent/Obligor's wages or commissions,
6 in the amount of \$ 467 per month.

7 2. That the Respondent/Obligor is not obligated to pay
8 child support and/or arrearages by immediate wage withholding
9 for the following reason:

10 () The Court which issued the order for support
11 lacked personal jurisdiction over the Respondent/Obligor;

12 () There was a mistake of fact as to whether the
13 responsible parent has been delinquent in the payment of support;

14 () There was a mistake of fact as to the amount of
15 the arrearages or support;

16 () There was a mistake of fact as to the custody of
17 the child/ren;

18 () The order of support was obtained by fraud.

19 3. () Unless a stay of this Order is obtained from the
20 District Court, wage withholding shall be undertaken upon entry
21 of this Order.

22 **IT IS FURTHER RECOMMENDED THAT:**

23 Δ DISPUTES THE AMOUNT OF ARREARAGES.
24 ARREARAGES WERE SET AT \$17,404 FROM
25 PREVIOUS ORDER THROUGH NOV 1999. Δ WILL
26 BE GIVEN CREDIT FOR ANY DOCUMENTATION
27 THAT HE PROVIDES RELATIVE TO DISPUTED
28 ARREARS AMOUNTS.
