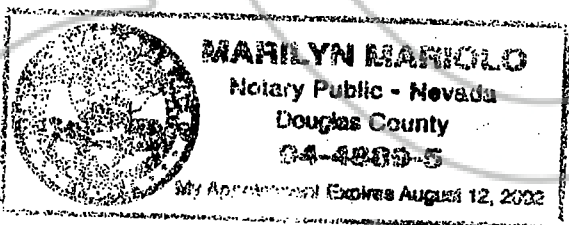

16 Court on an Order to Show Cause Under Uniform Reciprocal
17 Enforcement of Support Act on the 25th day of May, 1982,
18 Plaintiff being represented by Michael J. Roeser, Deputy
19 District Attorney for Douglas County, Nevada, and Defendant
20 being represented by Jack Sheehan, Attorney,

21 THE COURT ORDERS AS FOLLOWS:

22 1. Defendant shall pay the sum of \$100.00 per month
23 per child for the support of his minor children TERRY JASON
24 BARTELS, born 3/28/70, and MARCHEL JANENE BARTELS, born 7/10/72,
25 for a total of \$200.00 per month.

26 2. Defendant shall pay an additional sum of \$100.00

16 should the Defendant fail to make an equivalent of two (2)
17 monthly payments in any twelve (12) month period.
