TRUSTOR PROMISES AND AGREES that: if trustor should transfer, sell, hypothecate, alienate, contract to sell or otherwise dispose of or lose title to the above-referenced Property; or any interest therein, in any manner or way, whether voluntary or involuntary; or if trustor becomes insolvent or makes a general assignment for the benefit of creditors: or if a petition in bankruptcy is filed by or against trustor, or if a proceeding be voluntarily or involuntarily instituted for other debtor relief provided for by the bankruptcy act; then upon the happening of any of such events, the beneficiary at their option may declare all promissory notes, sums and obligations secured hereby immediately due and payable without demand or notice, irrespective of the maturity dates expressed therein, and beneficiary or trustee may record a notice of such breach or default and elect to cause said Property to be sold to satisfy the indebtedness and obligations secured hereby.
- 3. Trustor shall perform all of Trustor's obligations under the Constituent Documents. The "Constituent Documents" are the (i) Declaration or any other document which creates the Condominium Project or Planned Unit Development and any homeowners association or equivalent entity, (ii) by-laws, (iii) code of regulations, and (iv) other equivalent documents. Trustor shall comply with the provisions of any homeowners association or equivalent entity formed for the mutual benefit of the subdivision or Planned Unit Development. Trustor shall promptly pay, when due, all dues and assessments imposed pursuant to the Constituent Documents.
