APPROVAL OF SETTLEMENT

The Petition of MARK W. KNOBEL for FIRST ACCOUNT, REPORT OF ADMINISTRATOR, PETITION FOR ITS SETTLEMENT, FOR PARTIAL ALLOWANCE OF ADMINISTRATOR'S FEES, ATTORNEYS' FEES AND COSTS AND FOR PARTIAL DISTRIBUTION, CONFIRMATION OF SALE AND APPROVAL OF SETTLEMENT came on regularly for hearing this date. No person appeared to contest the Petition. - 1. That the Petition for First Account, Report of Administrator, Petition for its Settlement, for Partial Allowance of Administrator's Fees, Attorneys' Fee and Costs and for Partial Distribution, Confirmation of Sale and Approval of Settlement is settled, allowed and approved as filed.
- 2. That all acts and proceedings of the Petitioner, as Administrator of the decedent's Estate, are ratified, confirmed and approved.
- 3. That the settlement of the Bette Cook judgment for One Thousand, Five Hundred and NO/100s Dollars (\$1,500.00) is approved, authorized, ratified and confirmed, and the allocation of the \$1,500.00 in settlement funds solely to Donna Gray is approved, authorized, ratified and confirmed.
- 4. That the Petitioner is authorized and directed to establish a reserve of at least Forty-five Thousand and NO/100s Dollars (\$45,000.00) to be maintained pending resolution of the claims for fees by the special administrator and Gloria Petroni, Esq.
- 5. That the Petitioner's statutory commission and fees for ordinary and extraordinary services is ratified, confirmed and approved in the total amount of Twenty-Five Thousand Three Hundred and Sixty-Nine and 22/100s Dollars (\$25,369.22) and said commission shall be paid as provided in six below.
- 6. That the Petitioner is authorized and directed to pay himself Twenty-Two Thousand and NO/100s Dollars (\$22,000.00) as and for partial payment of his total statutory commission, and that Petitioner be further authorized and directed to pay himself the

balance of his commission once the reserve is released and an order for final distribution is obtained.

- 7. That the Petitioner is authorized and directed to reimburse the law firm of Avansino, Melarkey, Knobel and Mulligan the amount of Seven Hundred and Nine and 83/100s Dollars (\$709.83) for actual out-of-pocket costs advanced to the Estate.
- 8. That the Petitioner is authorized and directed to pay the law office of Mark Pfotenhauer, Esq. the amount of Four Thousand and Sixty and NO/100s Dollars (\$4,060.00) as and for attorney fees and Four Hundred and Eighty-One and 52/100s as and for costs advanced to the Estate.
- 9. That the sale of decedent's vehicles at auction is ratified, confirmed and approved.
- 10. That distribution of decedent's tangible personal property, valued at \$1,500.00, without bond, to JANE FARAOLA from her share of the estate is ratified, confirmed and approved.
- 11. Petitioner is further authorized and directed to make a cash distribution, in an amount of not less than One Hundred and Eight Thousand, Four Hundred and Seventy-Eight and 04/100s Dollars (\$108,478.04) to decedent's adult children, to be shared equally, in order to equalize the distribution at two-thirds to decedent's adult children and onethird to decedent's surviving spouse.
