- 7. That the payment of the notes secured by deeds of trust of estate property is in the best interest of the estate and the heir of the decedent; and
- 8. That after payment of the notes and fees to Petitioner and his attorney, the estate will be in a condition to be finally settled and distributed.

IT IS THEREFORE ORDERED:

- 1. That notice of the hearing on the First and Final Account and Petition for Fees and for Final Distribution is dispensed with;
