**RESOLUTION OF DOUGLAS COUNTY, STATE OF NEVADA
APPROVING CHANGE OF STREET NAME OF THE "WATERLOO
LANE EXTENSION" TO STODICK PARKWAY**

WHEREAS the Waterloo Lane extension is a planned roadway within the Douglas County Master Plan;

WHEREAS Douglas County has requested to name the future street Stodick Parkway;

WHEREAS the Douglas County Community Development Department has determined that the name Stodick Parkway is not used to identify any other street within Douglas County;

WHEREAS the street name change will allow for convenient, effective and safe provision of emergency, postal and public services;

NOW, THEREFORE BE IT RESOLVED that the Douglas County Board of Commissioners hereby approves a street name change for the future Waterloo Lane extension, to the East of US 395, to Stodick Parkway (refer to Exhibit A).

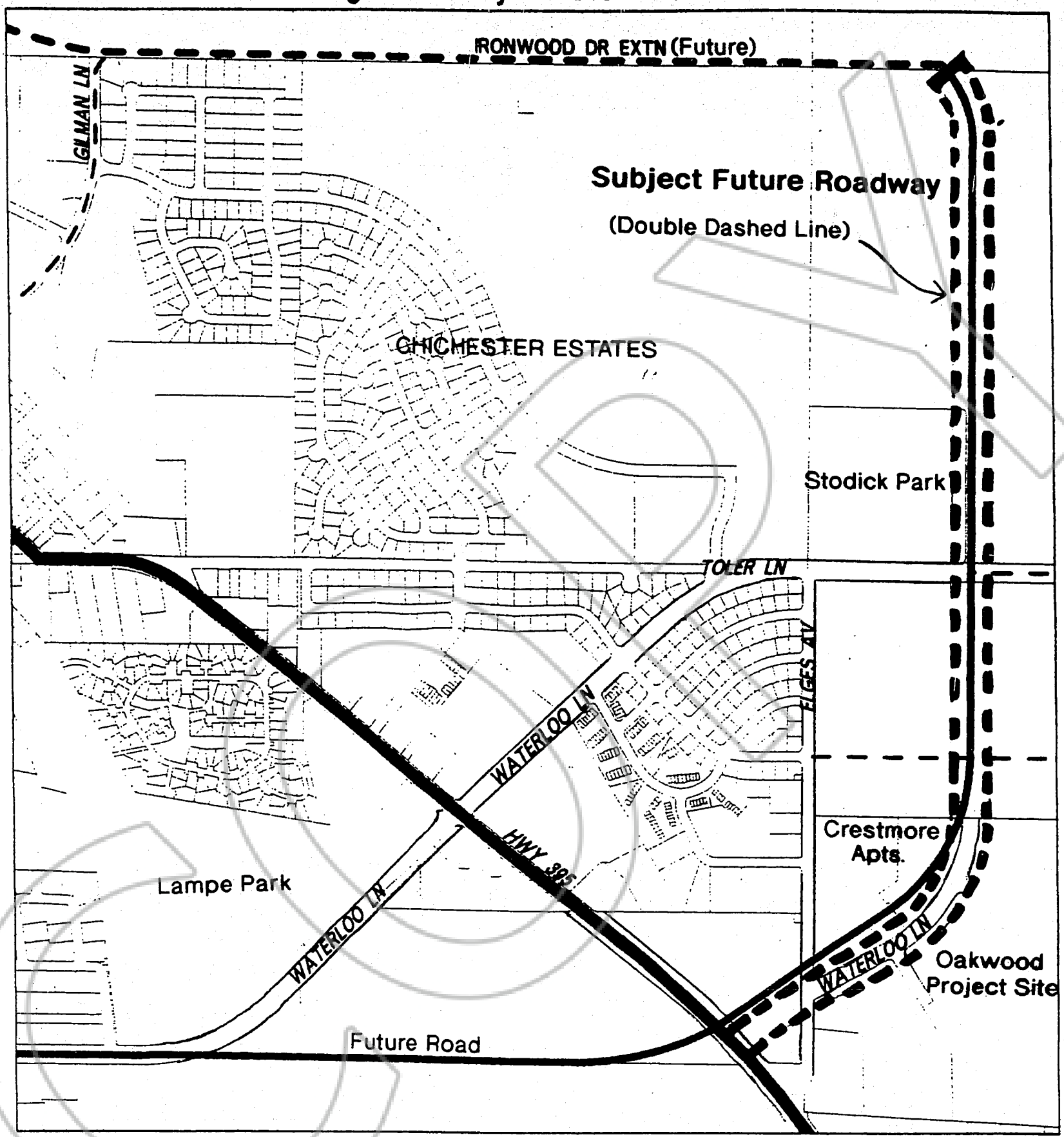
