One Hundred Seven and 25/100 Dollars (\$107.25), and reasonable attorney's fees. The Court has reviewed Plaintiff's application as well as all other documents filed in this case. Considering the evidence presented, the Court finds as follows:

- 1. Defendant was served as prescribed by law, a copy of the Summons and Complaint being personally served upon Defendant on March 22, 2000.
- 2. Defendant has failed to plead or otherwise defend as required by law.
