15 An Application for Default Judgment has been filed with this
16 Court by Plaintiff First Security Bank of Nevada, successor in
17 interest to Nevada Banking Company, ("Plaintiff"), pursuant to
18 which Plaintiff requests this Court to enter a Default Judgment
19 against Defendant Ronald E. Ficklin, doing business as Oasis
20 Landscape Management, a sole proprietorship, ("Defendant"), in the
21 principal amount of Four Thousand Fifty Six and 37/100 Dollars
22 (\$4,056.37), together with prejudgment interest as of February 16,
23 2000, of One Hundred Twenty One and 80/100 Dollars (\$121.80), plus
24 interest from February 17, 2000, through the entry of judgment at
25 \$1.2676 per diem, late charges of Sixteen and 00/100 Dollars
26 (\$16.00), postjudgment interest at the statutory rate from the date
of entry until the judgment is paid in full, costs in the amount of

1 One Hundred Seven and 25/100 Dollars (\$107.25), and reasonable
2 attorney's fees. The Court has reviewed Plaintiff's application as
3 well as all other documents filed in this case. Considering the
4 evidence presented, the Court finds as follows:

5 1. Defendant was served as prescribed by law, a copy of the
6 Summons and Complaint being personally served upon Defendant on
7 March 22, 2000.

8 2. Defendant has failed to plead or otherwise defend as
9 required by law.

10 3. Pursuant to Rule 55(a) of the Nevada Justice Courts'
11 Rules of Civil Procedure, a Default was entered by the Clerk of
12 this Court on April 13, 2000.

13 4. Pursuant to Rule 55(b)(1) of the Nevada Justice Courts'
14 Rules of Civil Procedure, Plaintiff filed with this Court proper
15 Application for Default Judgment.

16 5. Plaintiff's Complaint, filed with this Court on March 10,
17 2000, against Defendant is for a sum certain and for a sum which
18 can, by computation, be made certain.

19 6. The amount sought by the Plaintiff's Complaint is the
20 principal sum of Four Thousand Fifty Six and 37/100 Dollars
21 (\$4,056.37), together with prejudgment interest as of February 16,
22 2000, of One Hundred Twenty One and 80/100 Dollars (\$121.80), plus
23 interest from February 17, 2000, through the entry of judgment at
24 \$1.2676 per diem, late charges of Sixteen and 00/100 Dollars
25 (\$16.00), and postjudgment interest at the statutory rate from the
26 date of entry until the judgment is paid in full.

1 7. Plaintiff attorneys have advanced the sum of One Hundred
2 Seven and 25/100 Dollars (\$107.25) for costs in this action as
3 shown on the Verified Memorandum of Costs filed herewith.

4 8. Plaintiff has submitted the affidavit of its attorney
5 documenting attorney's fees to date in the amount of One Thousand
6 Two Hundred Fifty and 00/100 Dollars (\$1,250.00).

7 Based upon the pleadings and evidence before the Court, and
8 good cause appearing;

9 IT IS HEREBY ORDERED, ADJUDGED and DECREED that Plaintiff is
10 granted judgment against Defendant as follows:

11 1. For the principal sum of Four Thousand Fifty Six and
12 37/100 Dollars (\$4,056.37), together with prejudgment interest as
13 of February 16, 2000, of One Hundred Twenty One and 80/100 Dollars
14 (\$121.80), plus interest from February 17, 2000, through the entry
15 of this Judgment at \$1.2676 per diem, and late charges of Sixteen
16 and 00/100 Dollars (\$16.00);

17 2. For postjudgment interest at the statutory rate, from the
18 date of the entry of this Judgment until this Judgment is paid in
19 full;

20 3. For costs incurred in prosecution of this lawsuit in the
21 sum of One Hundred Seven and 25/100 (\$107.25); and

22 4. For the sum of _____
23 _____ (\$ 250⁰⁰) as a reasonable attorney's
24 fee.
