SHORT FORM DEED OF TRUST WITH ASSIGNMENT OF RENTS

THIS DEED OF TRUST, made MAY 4 00, between West Ridge Homes, Inc, A Nevada Corporation, whose address is 1528 Hwy 395 Suite 215 GARDNERVILLE, NV 89410, herein called TRUSTOR, STEWART TITLE CO., INC OF DOUGLAS COUNTY, herein called TRUSTEE, and Richard M Doud Contr's Pension Plan R. DOUD, TRUSTEE; herein called BENEFICIARY,

WITNESSETH: That Trustor irrevocably grants, transfers and assigns to Trustee in trust, with power of sale, that property located in Douglas County, Nv described as:

Lot 25 in Block C as set forth on the Final Subdivision Map FSM #1006-6 of CHICHESTER ESTATES, Phase 6, filed for record in the office of the County Recorder of Douglas County, State of Nevada on February 16, 2000 in Book 0200, at Page 2552, as Document No. 486411, official records of Douglas County, Nevada.,

Together with the rights to all governmental permits or licenses of all types and all personal property whether affixed to the property or not which are necessary for the ordinary and intended use of the property, including but not limited to sewer and water hookup rights and water rights.
