12 This Court has reviewed plaintiff's Application for

14 and makes the following Findings and Order by way of default.

15 **AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS THAT:**

16 The Court has jurisdiction over the parties and the
17 subject matter of this case.

18 Defendant was personally served with a copy of a
19 Notice of Findings of Financial Responsibility on February 27,
20 2000.

21 Defendant has failed to answer, request a meeting with
22 the district attorney's office, child support division, or
23 otherwise appear in this matter after being properly served.

24 Defendant is the parent of, and owes a duty of support
25 to: ZACKERY RYAN MCCOMB, born: 01/16/98.

2 Based upon the information provided by the State of
3 Nevada, defendant has an ability to earn \$1,068.00 per month
4 from unemployment benefits. That based upon defendant's monthly
5 income and applying the formulas set forth in NRS 125B.070, to
6 wit: 18%, defendant's monthly child support obligation is
7 \$192.24.

8 Defendant owes child support arrears in the amount of
9 \$2114.64 for the period May 1999 through and including March
10 22, 2000.

11 **THEREFORE, IT IS HEREBY ORDERED THAT:**

12 Defendant is the parent of, and owes a duty of support
13 to: ZACKERY RYAN MCCOMB, born: 01/16/98 SSN: [REDACTED] 0137.

14 Judgment is entered in favor of TAMMY SUSAN MCCOMB
15 and against defendant in the amount of \$2,114.64 for the period
16 May 1999 through and including March 22, 2000.

17 Defendant pay \$212.24 per month, by wage withholding,
18 to be paid as follows:

20 ARREARAGE PAYMENT:	\$ 20.00

26 **PAYMENTS MUST BE MADE TO THE DOUGLAS COUNTY CLERK AS FOLLOWS:**

27 Defendant's monthly child support payments shall be
28 in the form of a cashier's check, certified check, or money
order, or in cash. If the payment is in the form of cash, it
must be delivered to the Douglas County Clerk at her office in

1 Minden, Nevada. If the payment is in the form of a cashier's
2 check, certified check, or money order, it must be made
3 payable to the DOUGLAS COUNTY CLERK, must contain the
4 notation Case No. [REDACTED] 3365A (MCCOMB, SCOTT), and be either
5 mailed to the Douglas County Clerk at Post Office Box
6 218, Minden, Nevada 89423, or delivered to said County
7 Clerk at her office in the Old Minden Inn, 1594 Esmeralda
8 Avenue, Suite 105, Minden, Nevada.

9
10 Defendant secure and maintain medical health insurance
11 on the above named child/ren when available through employment
12 or other group policy. The defendant is ordered to provide the
13 Douglas County district attorney's office, child support
14 division information regarding the availability of health
15 insurance.

16 Custody of the minor child shall remain with the
17 mother, TAMMY SUSAN MCCOMB. This provision is made under the
18 authority granted in NRS 126.031, and is made for the protection
19 of the minor child/ren. That the Douglas County district
20 attorney's office does not have authority to litigate matters
21 regarding custody and visitation.

22 Defendant shall notify the Douglas County district
23 attorney's office of any change in defendant's home address,
24 mailing address, telephone number, employment, or medical
25 insurance availability within ten days of any change.

26 In accordance with 125B.055, plaintiff and defendant
27 are hereby ordered to file with the Court and with the district
28 attorney's office their social security number, residential and

1 mailing addresses, telephone number, driver's license number,
2 and the name, address and telephone number of their employer.
3

4 **IT IS FURTHER ORDERED THAT:**

5 Defendant's first monthly child support obligation
6 shall be due on the first day of April, 2000, and shall
7 continue due on the first day of each and every month
8 thereafter until further order of this Court.

9 When defendant's minor child emancipates, defendant
10 shall continue to pay \$212.24 per month toward satisfaction of
11 defendant's then existing child support arrears in accordance
12 with NRS 125B.100.

13 Defendant's ordered monthly payment on child support
14 arrearages does not preclude other methods of collection for
15 child support arrearages which may include, but are not limited
16 to wage withholding, garnishments, liens and the interception of
17 Federal Income Tax refunds, will be undertaken upon entry of
18 this Order.

19 This support order must be reviewed every three years
20 in accordance with NRS 125B.145 at the request of either party.
21
