

QUIT-CLAIM DEED

THIS INDENTURE, made and entered into this /s day of May, 2000, by and between MARY T. MCMULLEN, Trustee of THE JOSEPH AND MARY MCMULLEN FAMILY TRUST dated July 21, 1995 of Washoe County, Nevada ("Grantor"), and ANN M. SCOLARI ("Grantee").

WITNESETH:

That the said Grantor does, by these presents, REMISE, RELEASE AND FOREVER QUITCLAIM an undivided 2.768% interest unto the Grantee and to her assigns, in that certain real property situate in the County of Douglas, State of California, described as follows:
