16 ORDER SETTLING FIRST AND FINAL REPORT AND ACCOUNTING
17 AND PETITION FOR FINAL DISTRIBUTION
AND APPROVAL OF COSTS AND FEES

18 BE IT REMEMBERED that SHERRIE L. CARRICO, as Administratrix with Will Annexed
19 of the Estate of VALITA M. DUERKSEN, deceased, filed herein on March 31, 2000, her First and
20 Final Report and Accounting and Petition for Final Distribution and Approval of Costs and Fees, and
21 this Court, having considered the same and having examined the evidence in this matter, finds that
22 proper notice has been given in this matter; that all allegations in said account and petition are true
23 and correct, and all obligations of this estate have been fully paid or will be paid, except for certain
24 administrative costs and expenses to be herein allowed; that after allowance and payment of the
25 aforesaid administration costs and expenses, this estate will be in a condition to be finally settled and
26 distributed to the beneficiaries hereinafter named,

27 THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:

28 1. That the First and Final Report and Accounting and Petition for Final Distribution

1 and Approval of Costs and Fees filed by SHERRIE L. CARRICO, as Administratrix with Will
2 Annexed of the Estate of VALITA M. DUERKSEN, deceased, be, and the same is hereby finally
3 settled, allowed and approved, and all actions taken by the Administratrix with Will Annexed in
4 connection with the administration of the estate as set forth in the account and petition filed herein
5 on March 31, 2000, are hereby ratified and approved.

6 2. That JAMES M. O'REILLY has advanced the sum of Four Hundred Ninety-Two and
7 11/100 Dollars (\$492.11) as costs in connection with this estate matter and the Administratrix with
8 Will Annexed is hereby authorized and directed to reimburse JAMES M. O'REILLY for the same
9 amount out of the funds of this estate.

10 3. That the Administratrix with Will Annexed of this estate is hereby authorized and
11 directed to pay the following closing costs and expenses in this estate matter:

12 (a) To JAMES M. O'REILLY whatever sums are expended by said law firm for
13 publication of notice, certified copies, preparation of tax returns and the payment of any taxes as may
14 be determined to be due by the estate, and other winding up expenses in connection with closing this
15 estate, not to exceed Two Hundred Dollars (\$200);

16 (b) To JAMES M. O'REILLY attorneys' fees in connection with services
17 rendered to this estate in the amount of Seven Thousand Eight Hundred Six and 28/100 Dollars
18 (\$7,806.28).

19 4. That said Administratrix with Will Annexed is hereby authorized and directed to pay
20 and distribute all the personal and household effects of the decedent, as follows:
