

NOTICE AND CLAIM OF LIEN



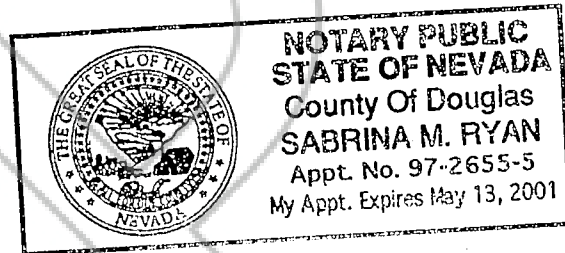
