Any litigation arising out of or relating to this Modification of the Note or Credit Agreement shall be commenced and conducted in the courts and in the State as specified in the Deed of Trust. Grantor hereby waives the right to trial by jury in any action brought on this Modification or on any other matter arising in connection with this Modification or Note or Credit Agreement.

NONTITLED SPOUSES AND NON-BORROWER GRANTORS. 
