STIPULATED JUDGMENT

IT IS HEREBY STIPULATED AND AGREED by and between FIRST SELECT CORPORATION, ("Plaintiff"), and LINDA L. SOWLE AND GEORGE L. SOWLE, ("Defendant(s)"), that Judgment be entered in favor of the Plaintiff and against the Defendant(s) for the amount of \$9,941.83, plus interest on the principal balance in the amount of \$1,549.35, along with Plaintiff's costs of suit in the amount of \$169.00, and Plaintiff's attorney's fees in the amount of \$250.00, together with interest on the principal balance at the mutually agreed contract rate of (23.9%) per annum from April 27, 2000 until this debt is paid in full.

It is further stipulated and agreed that this Judgment shall be paid as follows:


1. Payments shall be made in an amount of no less than \$53.57 per month by the 25th day of every month, with the first payment being due on or before May 25, 2000.


1 payment as previously stipulated, the terms of this agreement will no longer be in effect.
