MODIFICATION OF DEED TRUST

Grantor acknowledges and agrees that, as of the date of this Modification, the Deed of Trust is fully enforceable in strict accordance with the terms thereof, and there are no claims, setoffs, avoidances, counterclaims or defenses or rights to claims, setoffs, avoidances, counterclaims or defenses to enforcement of the Deed of Trust or the Note or Credit Agreement. Grantor acknowledges receiving a full and completed copy of this Modification (regardless whether Grantor's signature appears on the copy). "Grantor" means, jointly and severally, each person who executed or executes the Deed of Trust or Deed of Trust Modification. Any litigation arising out of or relating to this Modification of the Note or Credit Agreement shall be commenced and conducted in the courts and in the State as specified in the Deed of Trust. Grantor hereby waives the right to trial by jury in any action brought on this Modification or on any other matter arising in connection with this Modification or Note or Credit Agreement.

NONTITLED SPOUSES AND NON-BORROWER GRANTORS.
