It is further stipulated and agreed that this Judgment shall be paid as follows:


1. Payments shall be made in an amount of no less than \$292.00 per month by the 9th day of every month, with the first payment being due on or before February 9, 2000.

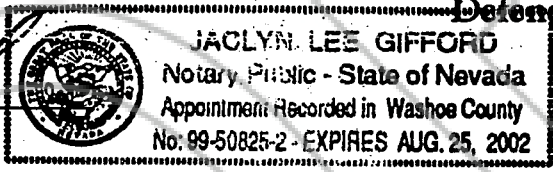
