WHEREAS, said amendment is at the request of both the COUNTY and the CONTRACTOR, and that significant benefit will be derived by the COUNTY from such adjustment; it is

NOW, THEREFORE, mutually agreed by both parties to Amend the original contract to address the adjusted COMPENSATION as hereinafter set forth:

Exhibit D1 - Amended Compensation Schedule


SECTION 4:


